2. Aggrieved by the decision of SRC in granting recognition for the academic session 2026-2027, the institution approached the Hon'ble High Court of Kerala in WP(C) No. 17822 of 2025 and the Hon'ble High Court vide its order dated 11th June 2025 has directed as under:-

"In view thereof, the writ petition stands allowed. The impugned Recognition Order dated 01.05.2025 in Ext.P12 is to be treated for the Academic Year 2025-26, and the petitioner College is directed to be included in the eligible list of the Institutions for allotment of students for taking admission for ITEP for the Academic Year 2025-26"

- 3. AND WHEREAS, the NCTE-HQrs had considered the matter and directed to adhere to the directions of the Hon'ble High Court of Kerala in W.P. No. 17822/2025 titled The Secretary Cum Manager, Majlis Arts And Science College (Autonomous) vs NCTE.
- 4. AND WHEREAS the matter was considered by SRC in its 466th meeting held on 16th July 2025 wherein the SRC decided as under :-

On careful perusal of the original file of the institution, NCTE Act, Rules, Regulations, directions of the Hon'ble Court, directions of NCTE-HQrs and guidelines of NCTE-HQrs published from time to time, the SRC decided that the Session mentioned in the Recognition order dated 01.05.2025 to Majlis Arts And Science College (Autonomous), Puramannur, Majlis Nagar, Tirur Taluk, Valanchery, Malappuram, Kerala-676552 be read as 2025-2026 instead of 2026-2027 for ITEP B.Com B.Ed Secondary (1 unit); B.Sc. B.Ed. Middle (1 unit); B.A. B.Ed. Preparatory (1 unit).
