He further explained that as per paper letter No. F2-10/2023(AC-Policy) dated 13-11-2023 from UGC and University Order No.19816/2023/Admn dated 22.12.2023, Majlis Arts and Science College has been conferred with Autonomy Status for a period of 10 years from 2024 Admission.

The Chairman explained in the meeting that Majlis Arts College is the first self-financing College in Kerala instituted by some philanthropist and again Majlis Arts and Science College is the first self-Financing Arts College to get Autonomous Status. On getting nominees from University of Calicut and Government of Kerala, the Governing Body was constituted and this is the very first meeting. Then all members acquainted themselves.
